# CRIME IN THE SPOTLIGHT

#### Burglary: 18-7684

On February 14, 2018, Deputy Ward responded to Gertrude Drive, Sunderland for the report of a burglary. The victim stated that an unknown suspect(s) had entered their shed and removed a burgundy colored generator and a Toro 48" Zero Turn riding lawnmower. The value of stolen property is \$7,000.

#### Damaged Property: 18-7962

On February 15, 2018, Deputy Gott responded to the Solomons Nursing Center, Solomons for the report of damaged property. The victim stated sometime between 2:00pm and 7:15pm on February 15<sup>th</sup> an unknown suspect(s) broke both the driver and passenger side windows out of their vehicle. The estimated damaged property is \$400.

#### Damaged Property: 18-8086

On February 16, 2018, Deputy Woodford responded to 7<sup>th</sup> Street, North Beach for the report of damaged property. The victim stated that sometime between 2:00am and 10:00am on February 16<sup>th</sup> an unknown suspect(s) used a sharp object to cut their driver's side rear tire. The estimated damaged property is \$200.

#### **Tampering: 18-7375**

On February 12, 2018, Deputy Sampson responded to Holland Cliffs Road, Huntingtown for the report of tampering. The victim stated that an unknown suspect(s) entered their unlocked vehicle and ransacked. It was determined that no items were stolen from inside the vehicle.



#### Arrest:

On February 12, 2018, Deputy Kreps responded to Giant, Dunkirk for the report of a theft. Deputy Kreps made contact with the stores Asset Protection employee who had the shoplifter in custody. They stated the observed the female later identified as **Jessica Lattin (35)** of Lothian using the bag and scan shopping option in the store however, she was not scanning all the items before putting them in the bag. It was determined there was \$588 worth of items not scanned in the cart. Lattin was placed under arrest and transported to the Calvert County Detention Center and charged with Theft: \$100 to under \$1,500.



On February 12, 2018, Deputy Ostazeski responded to the area of the Tavern, St. Leonard for the report of tampering with a motor vehicle. The victim had stated he saw the suspect later identified as **Douglas Jones (27)** of Lusby inside his vehicle, but then got out and remained standing behind the vehicle. Deputy Ostazeski attempted to make contact with Jones, when Jones began to walk away and started yelling. Jones began resisting arrest when Deputy Ostazeski began to place him into handcuffs. Jones was transported to the Calvert County Detention Center and charged with Intoxicated Endanger, Intoxicated Public Disturbance, Disorderly Conduct, Obstructing and Hindering, Resist/ Interfere with Arrest, Assault-Second Degree, Fail to Obey Reasonable/Lawful order of Law Enforcement Officer.

On February 14, 2018, Deputy J. Ward responded to ABD Liquors, Prince Frederick for the report of a disorderly subject. Deputy Ward made contact with an employee who advised the male later identified as **Harley Frost (28)** of Chesapeake Beach had cashed a fraudulent check. Frost explained to Deputy Ward that he was forging the checks that he had stolen. Frost was placed under arrest and transported to the Calvert County Detention Center and charged with Theft: Less Than \$100, Forgery of Private Documents, and Issue False Documents.

On February 15, 2018, Deputy Rediker responded to the K-Mart, Prince Frederick for the report of a theft. Deputy Rediker made contact with the security personnel for the store who advised an employee had been stealing from the store. The employee identified as **Jennifer O'Connor (39)** of Bowie advised Deputy Rediker of the fraudulent transactions including merchandise from the store and cash/credit refunds to herself. O'Connor was placed under arrest and transported to the Calvert County Detention Center and charged with Theft Scheme: \$100 to \$1,500 and Theft: \$100 to under \$1,500.

On February 16, 2018, Deputy Ridgley was on patrol when Emergency Communications dispatched a lookout for a vehicle operated by a possible intoxicated driver. Deputy Ridgley located and observed the vehicle and the conducted a traffic stop in the area of Hallowing Point Road and Tate Road. The driver later identified as **James Smith (49)** of Huntingtown agreed to perform The Standardized Field Sobriety Tests and a K9 scan of the vehicle was conducted. The K9 scan resulted in a positive alert and a search of the vehicle and Smith was completed. The search resulted in a zip lock bag containing multiple pills. Smith was placed under arrest and transported to the Calvert County Detention Center and charged with CDS Possession with Intent to Distribute.

On February 16, 2018, Deputy Parks responded to a traffic stop in the area of Prince Frederick Boulevard and Ruby Tuesdays Restaurant, Prince Frederick. The occupants of the vehicle later identified as **Michael Chavis (20)** of Prince Frederick and **Austin Whitney (19)** of Port Republic where advised to step out of the vehicle for a K9 scan to be conducted. The K9 scan resulted in a positive alert and a search was conducted. Both subjects had narcotics on their persons. Chavis and Whitney were both placed under arrest and transported to the Calvert County Detention Center and charged with CDS: Possession-Not Marijuana (cocaine).

On February 17, 2018, Deputy Yates conducted a traffic stop in the parking lot of the Greene Turtle, Prince Frederick. While making contact with the driver, Deputy Yates could smell a strong odor of marijuana. The driver and passenger later identified as **Ashley Banks (21)** of Leonardtown were both asked to step out of the vehicle for a search to be conducted. Narcotics were located and Banks was placed under arrest. Banks was transported to the Calvert County Detention Center and charged with CDS Possession with Intent to Distribute, CDS: Possession-Not Marijuana (crack cocaine), Possession or Receive CDS while Confined, CDS: Possession of Paraphernalia.

On February 18, 2018, Corporal Wahlgren conducted a traffic stop in the area of Southern Maryland Boulevard and Dunkirk Drive for a vehicle speeding. After making contact with the driver later identified as **Keiona Carter (26)** of Virginia it was determined she was driving a rental car on a suspended license and had a possible warrant. Emergency Communications confirmed the active warrant and after speaking with the rental car company it was determined the vehicle had never been turned back in. Carter was placed under arrest and transported to the Calvert County Detention Center and charged with Motor Vehicle/ Unlawful Taking and the appropriate traffic citations.



**Possession of Crack Cocaine & Heroin:** On 2/6/18 at 11:18 pm, Corporal Esnes stopped a vehicle for traffic violations on Rt. 4 near German Chapel Road in Prince Frederick. Trooper First Class Rucker arrived to assist. A K-9 scan was requested and resulted in a positive alert. A probable cause search revealed Heroin. A secondary search at the detention center revealed a smoking device containing suspected crack cocaine. **Darryl W. Icenhower**, 25 of Lusby was arrested and incarcerated at the Calvert County Detention Center.

**Possession of Heroin:** On 2/10/18 at 3:52 pm, Trooper First Class Palumbo stopped a vehicle on Rt. 4 near Parran Road in Lusby for traffic violations. Because of several indicator observed, a K-9 scan of the vehicle was requested. The K-9 scan resulted in a positive alert. A search of the vehicle revealed suspected heroin. **David L. Capizzi**, 47 of Port Republic was arrested for possession of heroin and was incarcerated at the Calvert County Detention Center.

**Theft/Shoplifting / Possession of Drugs / Disorderly Conduct:** On 2/13/18 at 11:29 pm, Trooper First Class Robinson responded to the Walmart in Dunkirk for a reported intoxicated subject. **Debra M. Vaughn**, 28 of Baltimore was located and the investigation revealed numerous shoplifted items in her possession. A search prior to arrest revealed cocaine/alprazolam and Oxycotin. Vaughn was arrested and incarcerated at the Calvert County Detention Center.

**Possession of Marijuana:** On 2/16/18 at 6:32 am, Trooper First Class Matthews stopped a vehicle on Rt. 4 near Plum Point Road in Huntingtown for traffic violations. A strong odor of raw marijuana was emitting from inside the vehicle. A probable cause search revealed 12 grams of marijuana and .4 grams of (THC) marijuana oil. **Devontae M. Gray**, 23 of Suitland was arrested and incarcerated at the Calvert County Detention Center.

**House Party - Underage Drinking:** On 2/18/18 at 12:30 am, Trooper Foley responded to the 3700 block of Larkview Court in Dunkirk on a tip stating a possible underage drinking house party posted on Instagram. Investigation revealed the homeowner's were out of town. Nine (9) juveniles were issued Uniform Juvenile Civil Citations for the Alcohol Offense and three (3) 18 year old females were issued Adult Uniform Civil Citations for consuming alcohol. The seven (7) remaining people at the party did not consume alcohol. The individuals who were 18 years of age and had consumed alcohol were released to a sober driver. The juveniles were released to their parents.

<u>Unauthorized Use of Motor Vehicle:</u> On 2/18/18 at 1:22 am, Trooper Backus responded to the 7700 block of Pine Blvd. in Lusby for a reported unauthorized use of a motor vehicle. The victim advised that **John H. Branham Jr**., 29 of Lusby had removed the vehicle from the residence after being told previously that he would not be able to use it. A warrant/summons has been requested for Unauthorized Removal of Property for Branham Jr. Investigation remains open.
